1) Is the company insured with general liability and workers compensation insurance? Have them provide a copy of their certificate of insurance. Call their agent to verify.	YES! If a company is not insured, you could get stuck in a legal and financial mess if something goes wrong on your property.
2) Is the company legitimate and registered with the state? Check on the Michigan website at http://www.dleg.state.mi.us/bcs_corp/sr_corp.asp	YES! Search by "Grass Bandits" or our ID #D75874
3) Can they provide you with references in a timely manner?	YES! Just call or email to request references (313) 279-5370
4) How many years has the company been in business? Have they survived the test of time or will you be looking for a new service in 3 months?	We have been working in the industry since 2001 .
5) What type of machinery will they be using on your lawn?	We use industry standard commercial grade lawn equipment. We use zero turn riding mowers for the majority of our cutting, but also carry walk behind units. Although the idea of a riding lawn mower is frightening to some, <i>we guarantee great results and will do anything within reason to accommodate you and your property.</i> It is the poor operation of equipment, not the equipment itself that causes subpar results that people have experienced with other companies. We rigorously train our employees to deliver top notch workmanship.
6) What is the company's billing system like. Will you be informed when someone completed work on your property?	Our #1 goal of our billing system is to keep you informed at all times. Upon completion of each service visit, we will leave a "Service Receipt" behind letting you know what we did, when we were there, how much it cost, and your account balance. Account summary statements are always available upon request and will be sent out monthly for those with separate billing addresses.
